**ORDER**

1. As per the paper read(1) above, scheme and Syllabus of B A Economics programme (CBCSS-OBE) was implemented in affiliated colleges w.e.f 2019 admission.
2. Examination branch as per paper read (2) sought clarification on internal(CE) and external (ESE) mark for the Project work in the syllabus of B A Economics programme CBCSS-OBE implemented in affiliated colleges w.e.f 2019 admission, as the CE & ESE marks distribution given in the syllabus was contradictory with the provisions in clause 8.1 of the regulation for UG programmes under CBCSS-OBE w.e.f 2019.
3. As the regulation for UG Programmes under CBCSS-OBE w.e.f implemented 2019 is applicable to all UG programmes, the Vice Chancellor ordered to follow the existing criteria of CE,ESE as per regulation Clause 8.1 -" 20% weightage shall be given to Continuous Evaluation (CE) and 80% weightage shall be given to End Semester Evaluation (ESE)" for the aforementioned programme also
4. The Vice Chancellor after considering the matter in detail and in exercise of the powers of the Academic Council conferred under section 11(1) Chapter III of Kannur University Act 1996 accorded sanction to modify Internal & External marks of Project Work in the Syllabus of BA Economic Programme CBCSS-OBE implemented in affiliated colleges w.e.f 2019 admission, by following weightage of 80% for ESE and 20% for CE as per common regulations of UG programmes & the same is reported to the Academic Council
5. The U.O read(1) above, stands modified to this extent.


