ORDER

- 1. The Regulations for Post Graduate Programmes under CBCSS in University Teaching Departments/Schools, implemented w.e.f. 2023 admission and certain modifications were effected thereafter, vide paper read (1) above.
- 2. As per Clause 10.1 of the Regulations for Post Graduate Programmes under CBCSS in University Teaching Departments/Schools, implemented w. e. f 2023 admission, "....Condonation of attendance to a maximum of 10 days in a Semester subject to a maximum of two spells within a Programme will be granted by the Vice Chancellor...".
- 3. A proposal for amending the Regulations of UG/PG Programmes in Affiliated Colleges and PG Programmes in University Departments, permitting the Condonation of attendance shortage for a third time, subject to payment of a special fee was placed before the Academic Council. The Academic Council, vide paper read (2) above, approved the same and resolved to refer the matter of fixing the fee to the Syndicate.
- 4. The Syndicate, vide paper read (3) above, recommended to fix the maximum days for condonation, for a third time, as that of first and second condonation and to fix special fee as ₹2000/- (Rupees Two Thousand Only).
- 5. Subsequently, the Academic D Section, vide paper read (4) above, requested to make necessary modifications in the Regulations concerned, in tune with the resolution of the Academic Council & the Syndicate.
- 6. Accordingly, Clause No 10.1 of the Regulations for Post Graduate Programmes under CCBCSS

in University Teaching Departments/Schools, implemented w. e. f 2023 admission is modified as follows:

"Condonation of Attendance to a maximum of 10 days in a Semester subject to a maximum of two spells within a Programme will be granted by the Vice Chancellor. Condonation for third time shall also be granted for 10 days, after levying a special fee, amounting to ₹2000/- (Rupees Two Thousand Only)."

7. The Clause no 10.1 of the U.O.s read (1) above stands modified to this extent w.e.f. 2024 admission.
