ORDER

1. The Revised Regulations for Credit based Semester System for P.G. Programmes in affiliated Colleges has been implemented in this University with effect from 2014 admission vide paper read (1) and certain modifications were effected to the same vide paper read (3) above.

2. As per the paper read (2) above, the scheme, syllabus & model question papers for Master of Communication and Journalism (MCJ) Programme were implemented in the University under Credit Based Semester System .w.e.f. 2014 admission.

3. As certain anomalies were reported by the Examination Branch vide paper read (4) above, in the existing syllabus of MCJ implemented w.e.f. 2014 admission, with respect to pass condition, improvement of marks, the evaluation of the courses (CE&ESE) etc, the matter was placed before the Board of Studies for rectifying the defects.

4. The meeting of the Board of studies in Journalism & Mass Communication (Cd) held on 25-02-2016 , vide paper read (5) above, discussed the matter in detail and resolved to correct the anomalies in the existing MCJ Syllabus in line with the Kannur University -KUCBSS-PG 2014 Regulation vide papers read (1) & (3). The Board of Studies recommended that the Common PG Regulation shall be applicable to the MCJ Programme w.e.f 2014 admission for all the clauses except **Clause-13- Evaluation and Grading** , "20% marks shall be given to CA & the remaining 80% to ESE". As the question paper setting of 2014 admission 3rd Semester & 2015 admission 1st Semester is over, the Board decided to follow the existing MCJ syllabus for 2014 & 2015 admissions. The Board of Studies also resolved to approve the restructured syllabus by correcting the anomalies which will be effective from 2016-2017 admission onwards.

5. The Vice Chancellor after considering the matter in detail, and in exercise of the powers of Academic Council conferred under section 11 (1) of Kannur University Act 1996 and all other enabling provisions read together with has accorded sanction to implement the recommendations of the Board of Studies that the Common PG Regulation vide papers read(1)&(3) shall be applicable to the MCJ Programme w.e.f 2014 admission for all the clauses except **Clause-13- Evaluation and Grading , and to follow the existing MCJ syllabus for 2014&2015 admission** under Credit based Semester System in affiliated Colleges, subject to report to the Academic Council.

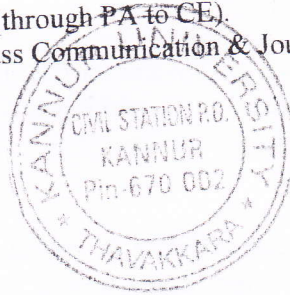


