ORDER

1. As per paper read (1) above, the Curriculum (2015 Scheme) of B.Ed. Programme (w.e.f 2015) was revised for conducting the III Semester Internship through Online mode and guidelines were implemented, in the backdrop of COVID 19 pandemic, for B Ed candidates of 2019-21 batch.

2. As the pandemic situation has not improved yet, the meeting of the Principals of the B.Ed. Colleges and Course Directors of Teacher Education Centres recommended to conduct III Semester B.Ed. internship for 2020-22 batch also, via Online mode. Further, the meeting entrusted Dr. Ashraf.T.P, Principal, Keyi Sahib Training College, Karimbam as per paper read(2), to prepare modified guidelines, by revising the same issued for the previous batch.

3.As per paper read (3) above, the Draft Guidelines for the conduct of Internship for B.Ed. 2020-22 batch, submitted by Dr. Ashraf.T.P, was placed before the Board of Studies in Education (Cd), for remarks.

4. As per paper read (4) above, the Board of Studies in Education (combined), recommended to implement the revised Guidelines for the conduct of the B.Ed. Internship [2020-22 batch], through online mode, as submitted by Dr.T.P.Ashraf.

5. The Vice Chancellor, after considering the matter in detail and in exercise of the powers of the Academic Council conferred under section 11(1) Chapter III of Kannur University Act 1996, accorded sanction to implement the revised Guidelines for the conduct of III Semester B.Ed. Internship for the B.Ed. candidates of 2020-22 batch, in the wake of the COVID 19 pandemic situation, subject to reporting to the Academic Council, as follows.

The Guidelines for the conduct of B.Ed. Internship during the COVID 19 pandemic situation for 2020-22 Batch in all Teacher Education Colleges/Centres affiliated to Kannur University

Introduction

Internship is a School-based experience programme and is given in various Schools during the third semester period. However, the schedule of Internship for the students of 2019-21 batches has got disturbed due to the closing down of Schools during the COVID 19 pandemic situations. As all the activities suggested during the internship period are to be carried out in School settings, an alternative way shall be adopted and activities can be completed in online/face-to face/blended mode. It is important to continue the educational process, making effective use of cutting edge technology and other available options, in the light of the UGC Guidelines on Examinations and Academic Calendar and NCTE guidelines to Teacher Education Institutions, to cope up with the COVID-19 Pandemic crisis.

Guidelines :

- i. Internship shall be arranged from 11.10.2021 to 31.12.2021.
- ii. Students are to develop 60 lesson plans : 40 lesson plans taught through online/offline platform in association with practice teaching school, 10 lesson plans of 30 minutes duration for peer teaching and 10 video lessons of 10-15 minutes duration.
- iii. Two lesson plans of 30 minutes duration shall be prepared and submitted for Health & Physical Education; one each in Health and Physical Education. 10-15 minutes of video lessons, based on the developed lesson plans also shall be recorded and submitted.
- iv. Demonstration classes can be done by observing online classes (preferably on Victers Channel) or by direct observation of classes by Expert teachers, students also need to observe a minimum of 5 classes in Pedagogy course and lesson plans must be developed based on the observation.
- v. Criticism classes can be conducted through peer teaching strategy or evaluating the video lessons prepared by the students.
- vi. All other Internship activities (Practicum) can be provided in conjunction with the current online classes conducted by respective schools/digital classes on the Victers Channel/ Peer teaching conducted at College and students are to submit all the record related to Practicum mentioned in the Syllabus with the following modifications.

a) With regard to the submission of Action Research/Case study, "Each College shall identify a topic (optional wise) for Action Research/ Case study to be completed. The report shall be submitted individually for verification during the Practical Examination.

b) Working with school programme shall be modified as Working with College/School programme.

vii. Practical Examination shall be conducted in the second week of January 2022. The board shall observe and evaluate the teaching competency and other practical works of all candidates based on video lessons prepared by the candidate/Viva voce and demonstration of teaching skill before the board during Viva voce. All candidates should appear for a Viva Voce for the optional and Physical and Health Education.

6. The above mentioned revision is applicable only for B.Ed. 2020-22 batch candidates, due to closure of schools as a result of COVID-19 pandemic.

7. The U. O read (1) above stands modified to this extent.
