## ORDER

1. The revised Regulation for U.G programmes under Choice Based Credits and Semester System (OBE) for Undergraduate Programme was implemented w. e. f 2019 admission and certain modifications were effected there after vide papers read (1) above,

2. Subsequently, the Single Window Cell vide paper read 2, intimated that the XXV<sup>th</sup> Academic Council meeting held on 14.12.2022 permitted the candidate who have completed one UG Programme, either in Regular or Distance mode to take additional degree ,either in Regular or Distance mode, without cancelling their previous registration and such candidates can write previous supplementary examination simultaneously while doing the additional degree and requested to amend the Regulation concerned accordingly.

3. Further the XXIX th Academic Council vide paper read (4) above, also considered this matter along with the matter of extending this provision to the newly implemented UG Regulations and approved.

4. The minutes of the Academic council was approved.

5. Therefore, Regulation of UG Programme under CBCSS (KUCBCSSUG 2019 Regulation) is modified by adding a new clause, Clause 11.4 under the clause 11 (Award of Degree) as follows Clause 11.4 For Obtaining additional Degree through Regular/Distance mode.

"Those students who have completed one UG Programme (either in Regular or Distance mode) can acquire additional Degree, (either in Regular / Distance / Private registration mode), without cancelling their previous registration and such candidates can write previous supplementary examination simultaneously while doing the additional Degree."

6. The U.O. read as 1 above, stands modified to this extent.
