**ORDER**

1. The Regulations of Under Graduate and Post Graduate Programmes implemented under School of Distance Education w.e.f. 2011 admission were modified by fixing maximum duration for the completion of the programmes, at par with Regular UG/PG programmes vide paper read (1) above.
2. The XXVIII<sup>th</sup> meeting of the Academic Council held on 25/06/2024 vide item No.II (8) (paper read 2) above, while considering the Recommendation of the Examination Branch for granting one time mercy chance examination to the UG candidates of 2009-13 admissions, resolved to conduct Mercy chance examinations for students under School of Distance Education also, by levying sufficient fee. The matter of fixing fee in this respect was referred to the Syndicate.
3. Since the decision of the Academic Council was silent about the year of admission of the Students under School of Distance Education, for whom the Mercy chance examination is to be conducted, Remarks were sought from the Examination Branch in this matter and the Examination Branch vide paper read (3) above, expressed the willingness to initiate procedure for conducting Mercy chance examinations for eligible UG & PG students under School of Distance Education w.e.f.2011 admission, subject to the issuance of University Order in this regard from the Academic Branch.
4. Subsequently, the Remarks furnished by the Examination Branch was placed before the Standing Committee of Academic Council and the Standing Committee, vide paper read (4) above recommended to approve the aforementioned Remarks furnished by the Examination Branch.
5. Further, the meeting of the Syndicate held on 30/09/2024 vide paper read 5, considered the matter of fixing Re- Registration fees as well as Course wise Examination fees, to be levied from the 2009 admission to 2013 admission UG candidates, including the students under School of Distance Education for the conduct of one time Mercy Chance Examination and resolved to fix the Re-Registration fee as Rs. 5000/- (Rupees five thousand only) and Course fee as Rs. 2000/- (Rupees two thousand only).
6. The Resolution of the Syndicate vide item No.2024.754 was implemented.
7. Considering the matter in detail, the Vice Chancellor **accorded sanction to conduct one time Mercy Chance Examinations for eligible UG and PG students under School of Distance**

Education w.e.f.2011 admission, who have already crossed the maximum period for the completion of the Programme, by levying the Re-Registration fee of Rs. 5000/- (Rupees five thousand only) and Course wise Examination Fee as Rs. 2000/- (Rupees two thousand only).

8.The Examination Branch shall take further action for the conduct of one time Mercy Chance Examinations for eligible UG and PG students under School of Distance Education w.e.f.2011 admission, by levying the Fee, as mentioned in Para 7 above.

Orders are issued accordingly.


