**ORDER**

1.The revised Regulations for PG programmes in Affiliated Colleges under Choice Based Credit and Semester System (OBE) was implemented w.e.f. 2023 admission vide paper read (1) above.

2. As per the Clause 3.9, "Condonation" of the aforementioned Regulations, *"Students are eligible for the Condonation of shortage of attendance for a maximum of 14 days in a Semester subject to a maximum of two times during the whole period of Postgraduate Programme."*

3. Meanwhile, a proposal for amending the Regulations of UG/PG Programmes in Affiliated Colleges and PG Programmes in University Teaching Departments, permitting the Condonation of attendance shortage for a third time, subject to payment of a Special Fee, was placed before the Academic Council held on 25/06/2024 . The Meeting of the Academic council, vide the paper read (2) above, approved the same and resolved to refer the matter of fixing the fee to the Syndicate.

4. The Meeting of the Syndicate, vide paper read (3) above, recommended to fix the maximum days for condonation, for a third time, as that of the first and second Condonation and also to fix the Special Fee as ₹2000/- (Rupees Two Thousand only).

5. Subsequently, the Academic D Section, vide paper read (4) above, requested to make necessary modifications in the Regulations concerned, in tune with the resolution of the Academic Council & the Syndicate, w.e.f.2024 admission.

6. Accordingly, a new Clause No 3.9 (i), as follows is added to the Regulations for Post Graduate Programmes under CCBCSS in Affiliated Colleges, w.e.f.2024 admission.

**Clause 3.9 (i) Condonation of shortage of attendance for third time shall also be granted for 14 days, after levying a Special fee, amounting to ₹2000/- (Rupees Two Thousand only)."**

7. The U.O. read vide paper (1) above stands modified to this extent w.e.f. 2024 admission.
