ORDER

- 1.As per the paper read (1) above, Regulations for PG Programmes in University Teaching Departments were implemented w.e.f. 2023 admission.
- 2. As per the Clause No 11.3 of the Regulations, "On recommendation of the Department Council, Supplementary End Semester Examination may also be conducted within one month of the declaration of the Semester results. A student who was absent or has failed in the End Semester Examination of a Course can reappear for the Supplementary examination in order to save an year".
- 3. Meanwhile, as per the paper read (2) above, the Examination Branch sought clarification on the 'Session' of the Supplementary Examination envisaged as per the Clause No 11.3 of the approved Regulations of the PG Programmes in University Teaching Depts implemented w.e.f. 2023 admission.
- 4. Subsequently, the comments/remarks of the Heads of the Teaching Depts were sought on fixing the 'Session' of the Supplementary Examination as January / July as per the paper (3) above.
- 5. The Vice Chancellor, after considering the Remarks received in this respect, ordered to place the matter before the Standing Committee of the Academic Council.
- 6. The Standing committee of Academic Council vide paper read (4) considered the matter and recommended to defer the same to the Academic Council.
- 7. Subsequently, the XXIX th Meeting of the Academic Council vide paper read (5) above, considered the matter and resolved to fix the 'Session' of the Supplementary Examination as 'January / June'.

- 8. The Minutes of the Academic was approved by the Vice Chancellor and published.
- 9.Therefore the Session of the Supplementary Examination envisaged in the Clause 11.3 of the Regulations of the PG Programmes in University Teaching Departments implemented w.e.f. 2023 admission is fixed as 'January / June'.
