## **ORDER**

- 1. As per paper read (1) above, KU FYUGP Regulations and Curriculum Framework, 2024 were approved and implemented in Affiliated Colleges under the University w.e.f. 2024 admission.
- 2. As per Clause No 4.7 of the KU FYUGP Regulations and Curriculum Framework 2024, 'Depending upon the availability of academic and infrastructural facilities, the institutions may also admit a certain number of students who are registered for particular programmes in each semester, from the 3rd or 5th semester, by transfer method, if required, from other institutions subject to conditions as may be issued by the University'.
- 3. As per Clause: 4.8 of the KU FYUGP Regulations and Curriculum Framework 2024, The HEI can also enroll students from other recognized HEI who are already registered for a particular programme there, either through Regular/ Online/ Distance mode, irrespective of the nature of programme (Aided/ Self-Finance/ Autonomous), in certain Courses as per their choice depending upon the availability of infrastructure and other academic facilities. On successful completion of the Course, Credit may be transferred through the Academic Bank of Credits, or it may be communicated to the University against the unique ID provided by the University at the time of admission.
- 4. In tune with the Clauses No 4.7 & 4.8 of the KU FYUGP Regulations and Curriculum Framework 2024, the matter regarding the Transfer of Students admitted under School of Lifelong Learning in Kannur University to the eligible FYUG Programmes conducted in Regular Colleges in 3rd Semester, was placed before the Standing Committee of the Academic Council for consideration and the Standing Committee of the Academic Council as per paper read (2) above, recommended to place the matter before the Academic Council.
- 5. Subsequently, the Meeting of the Academic Council, held on 21/12/2024, as per paper read (3) above, considered the matter and approved the Transfer of Students admitted under School of Lifeling Learning in Kannur University to the eligible FYUG Programmes conducted in Regular Colleges, in line with the KU- FYUGP Regulations and Curriculum Framework 2024.
- 6. The Minutes of the Meeting of the Academic Council held on 21/12/2024 was approved by the

Vice Chancellor and published.

7. Hence, the Transfer of Students admitted under the School of Lifelong Learning of Kannur University, to the eligible FYUG Programmes conducted in Regular Colleges, in line with the KU-FYUGP Regulations and Curriculum Framework 2024 is approved and implemented w.e.f. 2024 admission.
